Brooktrout Authorized Reseller Program for TEC Terms and Conditions

Participation in the Brooktrout Authorized Reseller Program for TEC is subject to Brooktrout's approval and may be terminated or limited by Brooktrout, in its sole discretion, at any time.

Section I

The authorized reseller agrees to protect their TEC Authorized Reseller ID and password and not distribute it outside their firm.

- The authorized Reseller agrees to obtain the serial number of the card for which the license key is being ordered either via the label on the card or accessing the information with the TEC Update software tool available on the Brooktrout web site. This information will be required to place an order with a Brooktrout distributor.

The authorized Reseller agrees to receive the TEC License Key as an electronic drop ship from the distribution partner. This process requires:

- Receiving an email notification that the license file is available for download
- Accessing the TEC partner website from the link contained in the notification email
- Entering the TEC partner username and password
- Downloading the TEC license file

The authorized Reseller agrees to install the license key directly or provide support to their customer that is performing the install.

The authorized Reseller agrees that downloading the license key file constitutes delivery and agrees to pay the invoices from the distribution partner after the download occurs.

Brooktrout will maintain the TEC license key file on the Resellers website for 60 days after email notification or 30 days after the initial download.

Section II

Training

To become a Brooktrout Authorized Reseller for TEC, the Reseller agrees to participate in training and a demonstration of the required procedure outlined in Section I above. At the conclusion of the training and demonstration Brooktrout will issue a username and password to the Authorized Reseller and place the reseller on the authorized reseller list issued to Brooktrout's distribution partners.

Section III

Brooktrout, at its sole discretion, reserves the right to modify, add to, or discontinue all or a portion of the Brooktrout Authorized Reseller Program for TEC including participation requirements, benefits or other program elements. Reasonable notice of any such change will be provided to Authorized Resellers.

Brooktrout shall not be liable for any damages, including any lost profits or other incidental, special, indirect, direct, exemplary, punitive or consequential damages, arising out of Reseller's participation in the Brooktrout Authorized Reseller Program for TEC.

The laws of the Commonwealth of Massachusetts shall govern the Reseller's participation in the Brooktrout Authorized Reseller Program for TEC.

Section IV
